Kiryukhin & Partners Law firm is a dynamically developing company at the Russian market of legal services. We provide legal services to Russian and foreign companies in key areas of activity.

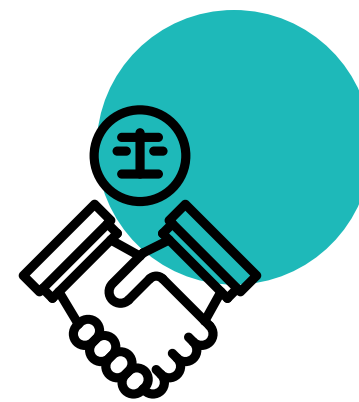
One of the main indicators of the quality of our work is the fact that 90% of our new clients contact us based on recommendations from current clients!

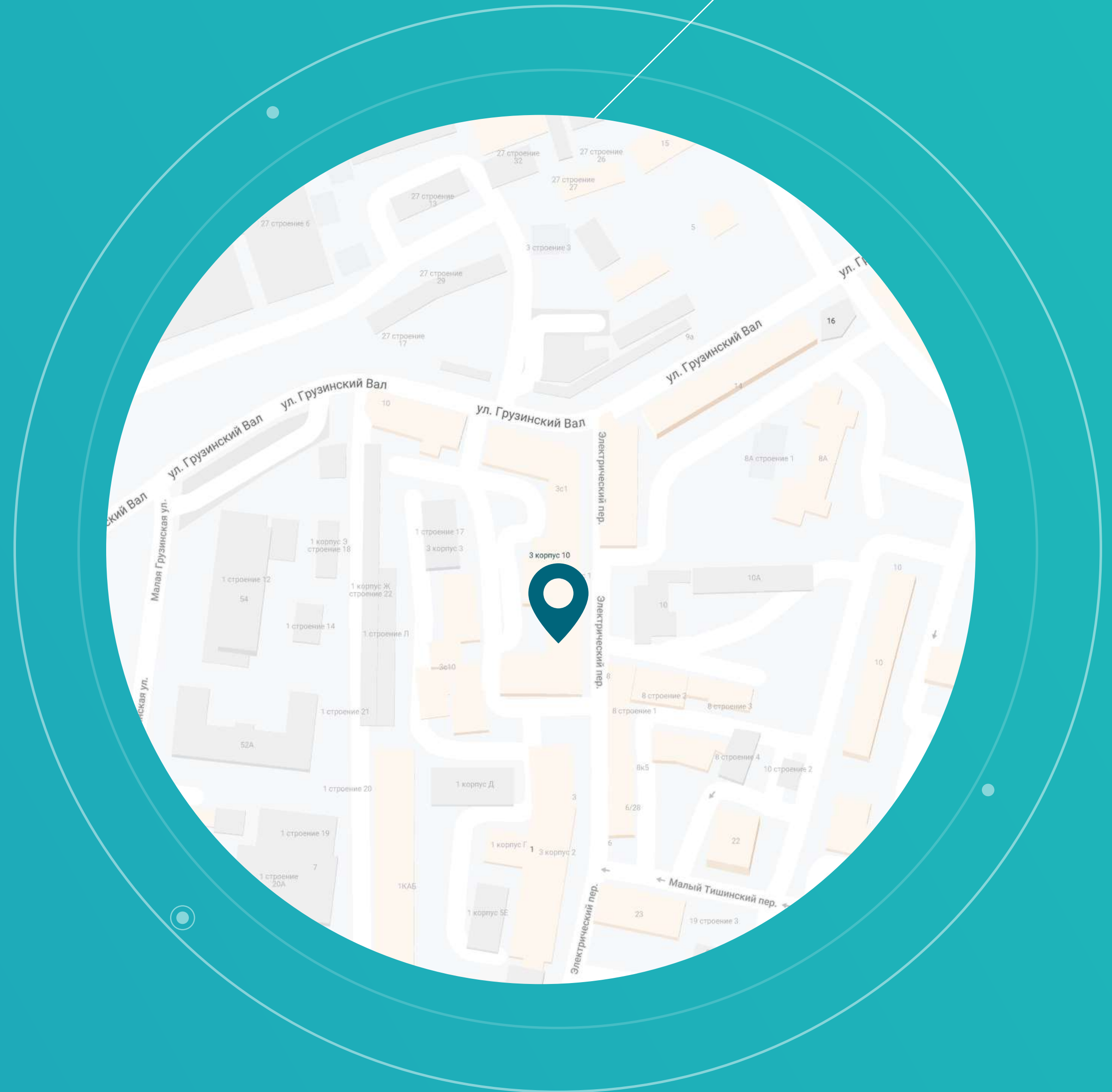
